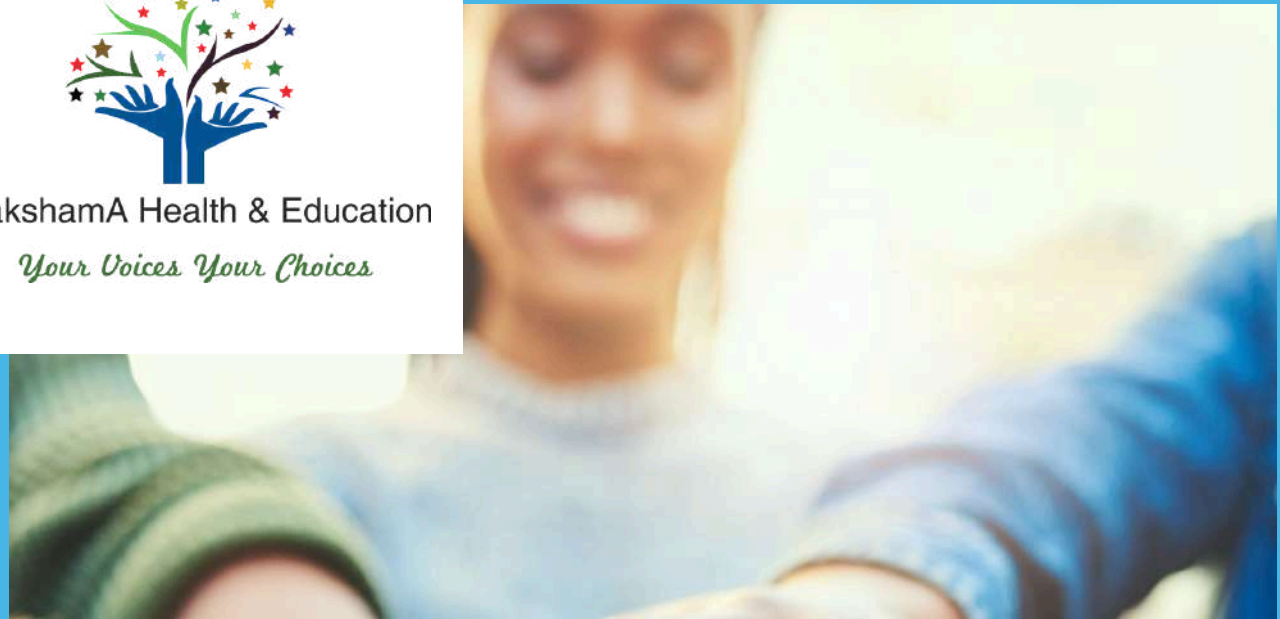

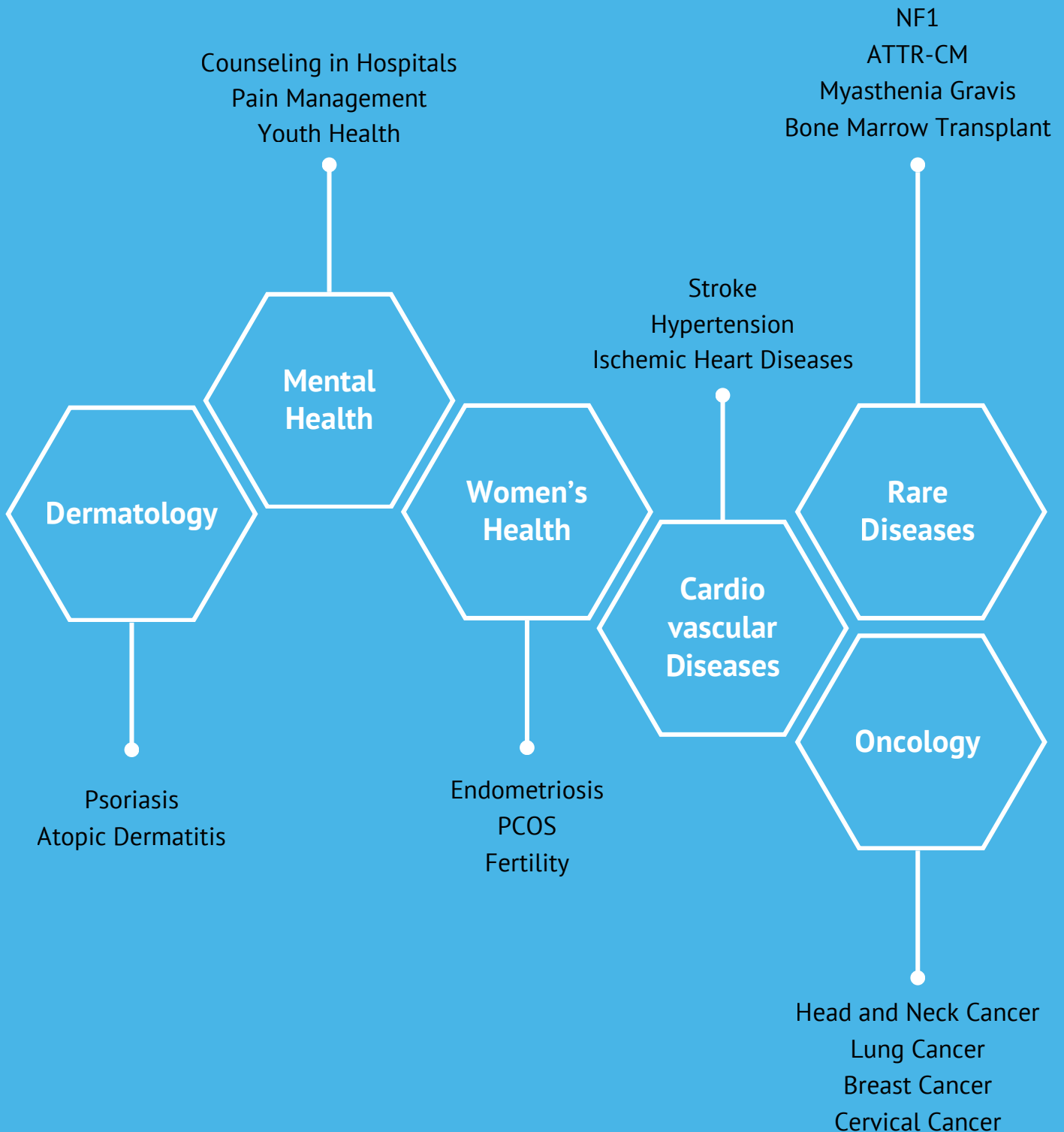

STEP UP FELLOWSHIP PROGRAM

The *Sustained Training & Education Project – Upgrading Physician Skills* project was designed to enhance surgical skills in arthroplasty and arthroscopy by supporting structured hands-on fellowship training across accredited hospitals in India.



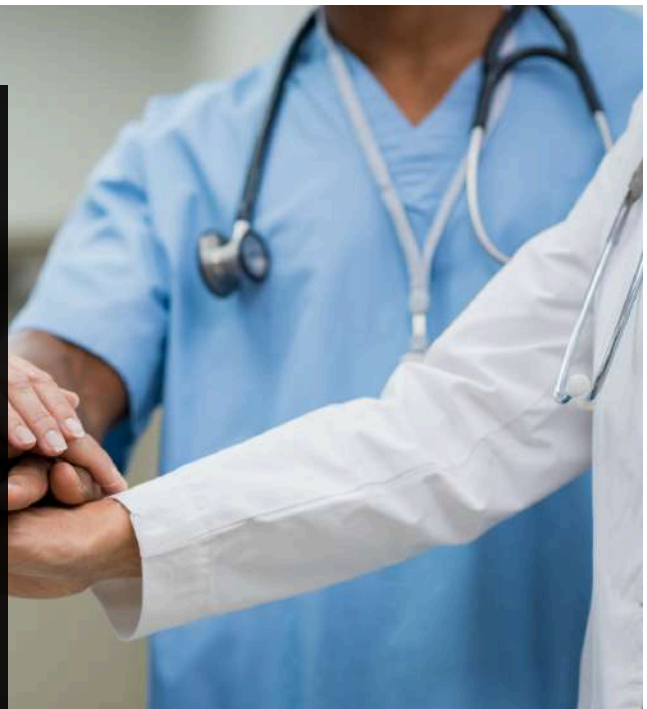
Our Success

Since the project launch in 2023, we have successfully trained a total of **40 fellows – 37 in Arthroplasty and 3 in Arthroscopy**. In 2025 itself, we have expanded the program by onboarding **24 new fellows**, significantly strengthening surgical training capacity and ensuring wider reach across both specialties.



The Reach

This initiative has been pivotal in advancing physician skills and aligns with our shared commitment to improving clinical excellence in India. The program is being implemented across **14 hospitals** in the country.



SPAN-HNC SUPPORT

A Brief about our project

The **SPAN-HNC (Screening, Patient Awareness, Nutritional Support- Head & Neck Cancers)** project is a CSR project being implemented by DakshamA Health since 2023, successfully tackling critical barriers in patient care by integrating counseling, nutrition support, awareness, and community engagement into a sustainable and replicable model.




Counseling and Holistic Mental Health Support

Our counselors stationed across 3 states in India have counselled over **1500 patients living with cancer**; alongwith conduction of **10+ patient experience sessions** such as music & art therapy, yoga & meditation, etc.



Community Awareness

Organized **32 Community Health Camps**, reaching **4,000+ individuals** in underserved communities to raise awareness on risk factors of HNC and distribute educational booklets.



Nutritional and Medical Support

Distributed **700+ nutritional supplements** to needy among HNC patients, as well as expanded care essentials to include items such as mouthwash and other hygiene materials, strengthening holistic supportive care.

POLICY ADVOCACY ON REUSE OF SUDS(SINGLE USE DEVICES)

THE PURPOSE

- To build regulatory momentum, improve ethical practices, and safeguard patient rights regarding the reuse of single-use medical devices (SUDs) in India.

THE PROGRESS

- Final white paper published and disseminated widely (publicly available).
- Stakeholder outreach expanded from 15 to 77 stakeholders, including parliamentarians, regulators, patient groups, and technical experts.
- High-level meetings conducted with:
 1. Director of Medtech Policy
 2. Joint Director, National Health Authority
 3. Patient Safety Secretariat, MoHFW
 4. Additional DG & Director (EMR), DGHS
- White paper shared with the Standing Committee on Health, IMPF, elected representatives, and CLRA.

KEY MILE STONES

- Meeting with Shri Kirti Azad, Chairperson, Standing Committee on Chemicals & Fertilizers (28 August 2025).
- Resulted in initiation of a draft Private Member's Bill proposing amendments to the Clinical Establishments Act and the Drugs & Cosmetics Act.
- Draft guideline framework for SUD reuse circulated for expert feedback.

THE TAKEAWAYS

- MoHFW formally acknowledged gaps in current regulation.
- CDSCO reiterated that SUDs cannot be reused and misuse constitutes an offence.
- No existing guidelines on safe reuse—creating space for policy change.

RARE REACH INITIATIVE

THE NF1 PROJECT

To build a robust support ecosystem for NF1 patients in India through awareness, early diagnosis, peer support, patient advocacy, and multi-disciplinary clinical coordination.



IMPACT SUMMARY

2025 marked a major acceleration in NF1-focused work at DakshamA Health – community formation, expert engagement, referral strengthening, and clear progress toward establishing a long-term national NF1 ecosystem. With advocacy, patient support, and diagnostic strengthening running in parallel, the project significantly deepened national visibility for NF1. **A formal MOU was signed with AIIMS New Delhi to support patient navigation.**

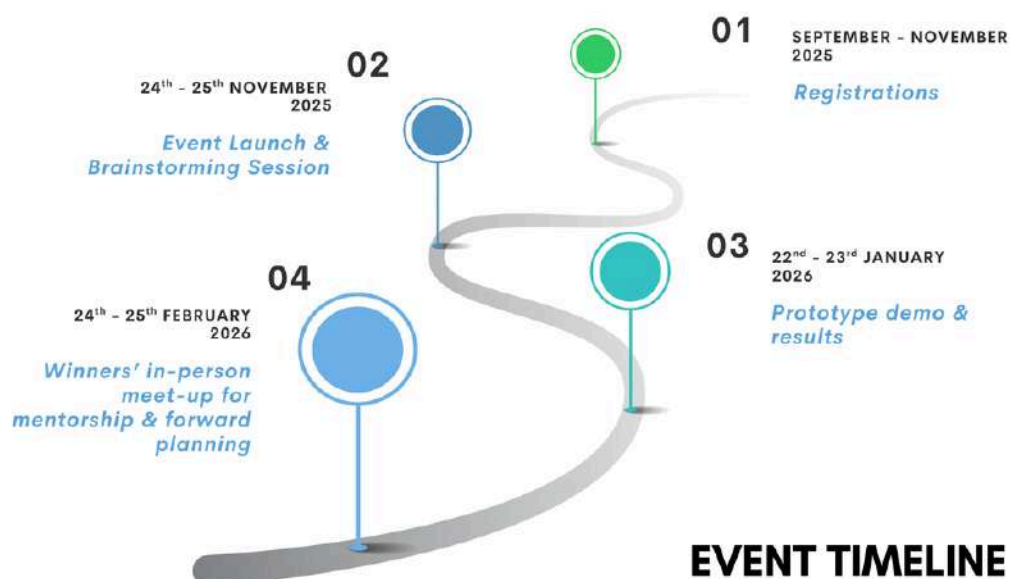
- **NF1 Support Group** formally launched with a growing community hosted via WhatsApp (**56** active members).
- Publication of the **first NF1 patient testimonial video** on YouTube – amplifying lived experience and public awareness.

- Three additional patient testimonies recorded and currently under editing.
- Organized **4 Patient Experience Sessions** and **2 Capacity-Building Sessions** for NF1 patients & caregivers.
- Conducted the **first NF1 Working Group Meeting**, initiating the formation of a clinical Multidisciplinary Team (MDT) for diagnosis, referral, and case management.
- Established **two NF1 referral desks**.
- Running an **active NF1 Helpline Desk**, a **Facebook support group**, and **Instagram page** (NF1 Warriors) for continuous patient support.
- Identified and mentored **2–3 NF1 patient advocates** – empowering them to participate in events and support the community.
- Supported **patient-led advocacy letters to government** requesting access and affordability reforms.

RARE IMPACT 2025

Rare Impact 2025 is a collaborative, *patient-inclusive virtual hackathon* focused on tackling the toughest challenges faced by people living with rare and genetic disorders.

Held under the Rare Reach Initiative of DakshamA Health in partnership with PAIR Academy, this event connected multi-stakeholders from *India, Vietnam, Thailand, Malaysia, Philippines, Singapore, and Nepal* to co-create digital tools, platforms, and systems that drive change.

HOW THIS WILL IMPACT THE CURRENT RARE DISEASE LANDSCAPE IN INDIA

Rare Impact 2025 is more than a hackathon – it is a systems-building initiative. By bringing together patients, clinicians, researchers, innovators, and policy experts, the event aims to catalyst for long-term transformation across the rare disease landscape in India and the Asia-Pacific region.

Elevating Patient Voice in Innovation

- Ensures solutions are co-designed with patients, not for them.
- Incorporates lived experience into tool building, strengthening relevance and usability.
- Trains patient representatives to participate in tech development, advocacy, and evaluation.



Enabling Scalable, Low-Cost Public Health Solutions

- Teams are encouraged to build lightweight digital tools that can be adopted by hospitals, NGOs, patient groups, and primary-care settings.
- Focus on open-source, interoperable, or policy-aligned designs.

Creating a Pipeline for Innovation & Policy Integration

- Solutions include early symptom identification, referral pathways, clinical decision aids, etc.
- Mentors from clinical specialties guide teams on accuracy and applicability.
- Tackle geographic and socioeconomic barriers that currently limit access.



INTERNATIONAL PATIENT SUMMIT 2025

The 2nd International Patient Summit held on March 7–8, 2025 in New Delhi, served as a landmark platform for advancing the conversation on health, climate change, and patient-centered action in the Asia-Pacific region. Organized under the theme “*Health, Climate, Community: Uniting Stakeholders for Action*,” the summit brought together over 600 registrants, including more than 130 in-person participants from 33 countries. The diverse audience featured patient advocates, policymakers, public health professionals, academics, and industry leaders—each committed to shaping resilient and inclusive health systems in the face of growing environmental challenges.

Over the two days, the summit featured a series of high-level panel discussions addressing a range of pressing topics—from universal health coverage and chronic disease management to mental health, digital health equity, and climate-responsive infrastructure. Conversations underscored how community data, local leadership, and technological innovation are essential to both preparedness and accountability. The active participation of speakers from the **Ministry of Health and Family Welfare, Government of India**, and the **World Health Organization** further validated the summit’s relevance on the global health agenda.

About PFPSN-India

Patients for Patient Safety Network – India (PFPSN-India) is a national patient-led platform working to advance safer, more transparent, and people-centred healthcare across the country.

The network brings together patients, caregivers, advocates, clinicians, public-health experts, and institutions committed to reducing preventable harm. DakshamA Health serves as the Secretariat for PFPSN-India and leads awareness activities, training, and system-wide advocacy on patient safety.

Purpose of the Webinar Series

The 2025 Patient Safety Webinar Series was launched to strengthen awareness, capacity, and public dialogue around critical patient-safety challenges in India.

Anchored to the WHO World Patient Safety Day 2025 theme – “Safe Care for Every Newborn and Every Child – Patient Safety from the Start” – the series focuses on ensuring safety across maternal, newborn, and child healthcare systems.

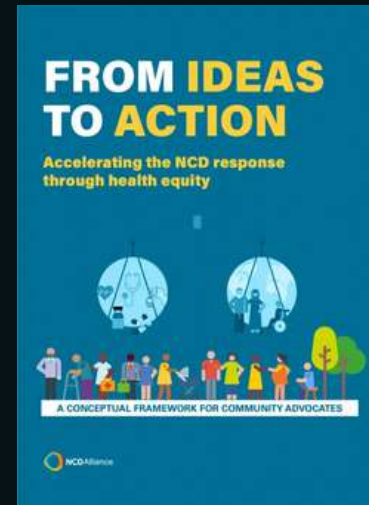
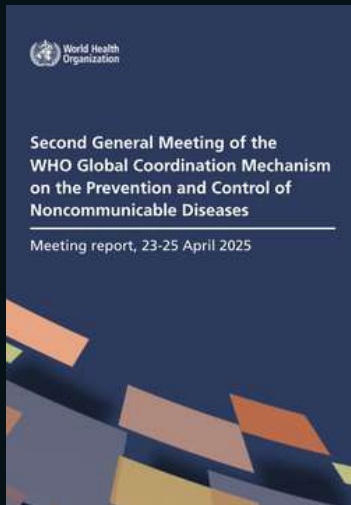
In addition to leading the Patient Safety Webinar Series under PFPSN-India, DakshamA Health was also invited to represent patient perspectives at the WHO Virtual Regional Workshop on Patient Safety: “Striving for Zero Avoidable Harm, Quality of Care, and Alignment with National Health Policy / IPC Strategy” held from 1–2 May 2025.

At this workshop, Dr. Ratna Devi delivered a session on “Patient Networks Driving Inclusion of Patient Voice into Patient Safety Programs”, highlighting how organised patient groups, including PFPSN-India, play a critical role in shaping safer healthcare systems. Her participation reinforced DakshamA’s commitment to embedding lived experience into national safety strategies and positioned the organisation as a regional leader in patient-centred safety advocacy.
